The Ordinance 2016-4 is in regards to the rate increases for water customers; which will happen in to phases in 2016. A copy of the ordinance will be included with the minutes.

Leslie mentioned if there had been any complaints about the water rate increase. Orville mentioned that he had some but that they were from customers in the rural part of the water system and the increase did not affect them. Leslie mentioned that his complaints had been from the same people.

Blake mentioned that a full time police office had a year to get to certified. Leslie mentioned that is not the case. Leslie also mentioned that the city had hired a gentleman and he had been a police officer many years ago and that he needed to be certified before starting a police career and that because he would not take the proper classes he had to be let go. Blake mentioned that he would start class in September. Lorene mentioned that Blake had no classes. Blake mentioned that he did not have any classes.
