Council Meeting

February 1, 2016

The regular monthly council meeting was called to order by Mayor Leslie King. Council members present: Laura King, Orville Lippe and Emmett Fickes Absent: Lorene Roberts, Lisa Heston Also present: Robb Hulsey/Police Chief Dalton Larson/Water Supervisor

*The minutes from the previous meeting was distributed and discussed. A motion was made by Laura, seconded by Emmett to accept the minutes from the previous meeting. All in favor. Motion carried. 3 Ayes

*The financial reports for the city and the water dept. were distributed and discussed. Laura mentioned the flag purchase. Leslie mentioned that it was purchased before christmas. Laura mentioned the gravel for Pine St. Gina mentioned that there was a water leak and that the street had to be cut for the repairing of the water line. A motion was made by Laura, seconded by Emmett to accept the financial reports. All in favor. Motion carried. 3/Ayes

Leslie mentioned that he had talked to the Highway Dept. and that they approved the street repair for \$230,000 and up to \$250,000. Leslie also mentioned that the only bad thing was that the streets would not be able to be done until March of 2017 because the Hwy Dept. is backed up. Laura mentioned who was doing the streets. Leslie mentioned that we would not know. Orville mentioned that the bids taken are only good for a certain amount of days usually thirty.

Leslie mentioned speaking to ANRC about the loans and trying to get the payments reduced. Leslie also mentioned that he had spoke with Tim Mays about the loans and he said that some times they will forgive an entire loan, which would help but getting the loan payments lowered would be better but what ever they do it will help. Leslie mentioned that he is suppose to hear something by Friday of this week.

Leslie mentioned the park and that Ward Barnes dug holes and that there are some more to dig to speed up process. Leslie also mentioned seeing if Ward would dig the other holes. Laura mentioned payment for Ward. Leslie mentioned that he donated his time.

Dalton mentioned that the dive team would be here February 2, 2015 to clean and inspect the wells.

Leslie mentioned that William came by and paid cash for the electric bills.

Orville mentioned ordering more base rock to fix some places in the roads and that if not used there that it would be used some where else. Leslie mentioned resurfacing for \$600.00, the bad place on Washington St. Leslie also mentioned that he does both asphalt and chip and seal. Dalton mentioned that the chip and seal is cheaper than the asphalt.

Leslie mentioned that the part of the flooring had been put in and that after the meeting the council should go look at it.

Laura mentioned that the Fire Dept. was very ungrateful about the flooring and the painting. Gina mentioned that Leslie and herself had to move the furniture and remove the carpet from the training

room and that she had to remove the carpet from the fire dept. office today. Leslie mentioned that he had been told that it would be removed by the fire dept.

No further business before the council. A motion was made by Laura, seconded by Emmett to adjourn the meeting. All in favor. Meeting adjourned. 3/Ayes
